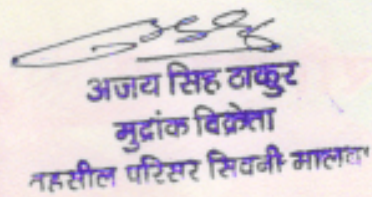

6. That the who will not open classes under CBSE pattern particularly 9,10,11,12 and will not use CBSE name in any manner without obtaining affiliation .
7. That the Principal and Correspondent/Manager of the school have individually gone through the provision, contained in the affiliation & examination byelaws and the circulars issued by the board from time to time.
